



# Vasona

## County Park

**Park Hours:** 8 am until sunset  
**Trail Hours:** Sunrise to sunset  
**Ranger Station and Visitor Station:** 408-355-2375  
In an emergency call 911

Fees are collected for vehicles. Fee schedule is posted at the entrance station.  
All boating must have mussel inspection and is allowed by permit only.

**Vehicles:** Observe speed limit at all times. Stay on designated roadways and parking areas.  
Parking is not permitted in unpaved areas.

**Dogs/Pets:** Allowed in all areas of the park on a maximum 6 foot leash.

**Fires:** Permitted in designated barbeque pits only. No fires on open ground or along shoreline. No wood gathering.

**Weapons:** Firearms, air guns, archery equipment and paintball guns are prohibited

**Alcohol:** Permitted in picnic and beach areas. All alcohol laws strictly enforced

**Smoking / Vaping:** Both prohibited with in the boundaries of the park.

**Swimming:** Prohibited in all lakes, streams, and reservoirs.

**Plants & Wildlife:** Collecting of plant specimens or animals is not permitted.

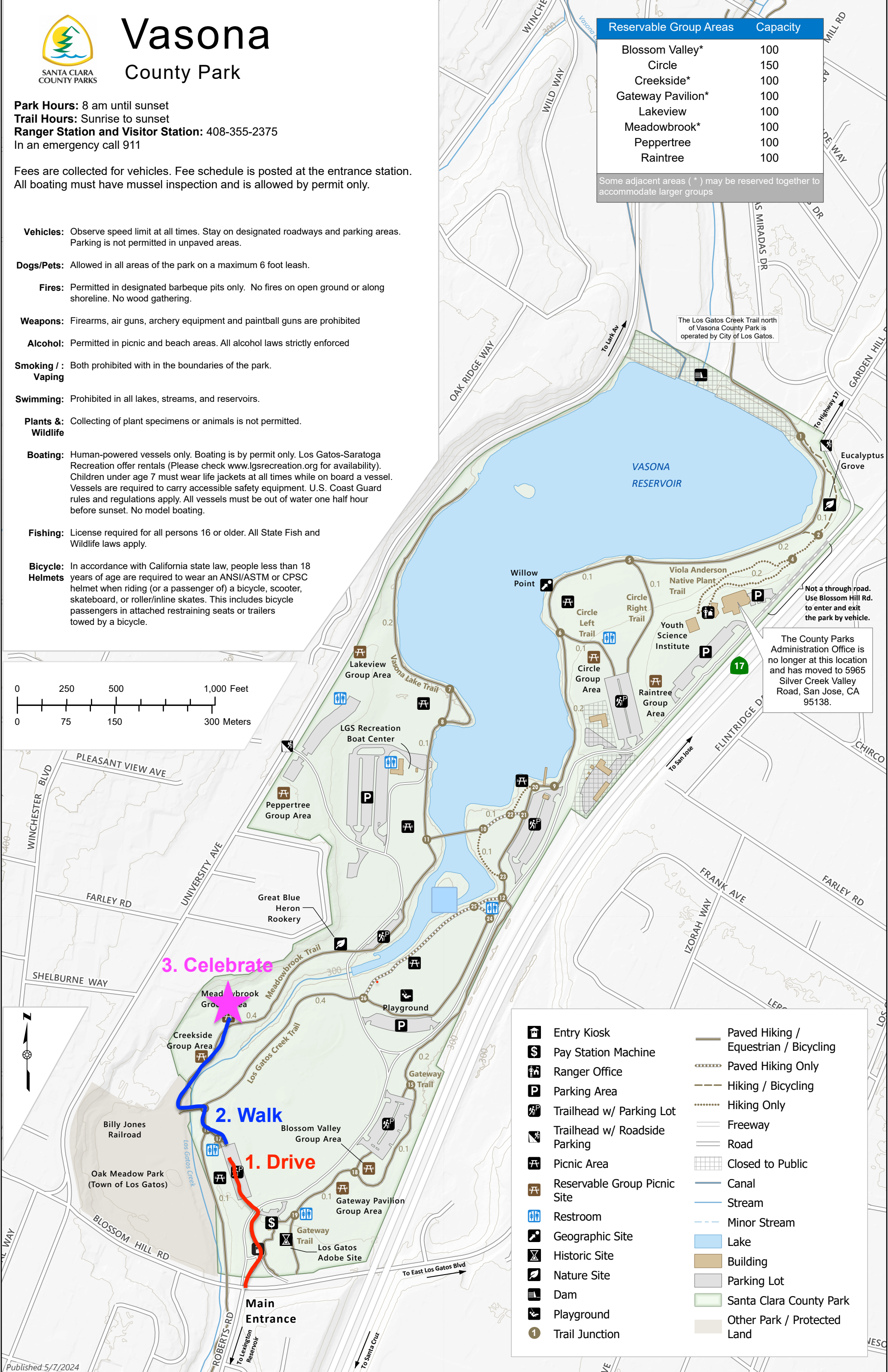
**Boating:** Human-powered vessels only. Boating is by permit only. Los Gatos-Saratoga Recreation offer rentals (Please check [www.lgsrecreation.org](http://www.lgsrecreation.org) for availability). Children under age 7 must wear life jackets at all times while on board a vessel. Vessels are required to carry accessible safety equipment. U.S. Coast Guard rules and regulations apply. All vessels must be out of water one half hour before sunset. No model boating.

**Fishing:** License required for all persons 16 or older. All State Fish and Wildlife laws apply.

**Bicycle Helmets:** In accordance with California state law, people less than 18 years of age are required to wear an ANSI/ASTM or CPSC helmet when riding (or a passenger of) a bicycle, scooter, skateboard, or roller/inline skates. This includes bicycle passengers in attached restraining seats or trailers towed by a bicycle.
